On 12/23/2025 at 08:37, I responded to a disturbance with a weapon reported from GREEN LEAF RIVER POINTE, 3508 NE 109TH AVE, W5, VANCOUVER, WA 98682.

Call notes stated FREDERICK HOWE was reporting that a female was assaulting him, and had a kitchen knife.

Upon arrival, Officers set up in front of the apartment, using parked cars as cover. We contacted TARA HOWE and Frederick, exiting apartment W5. Both Tara and Frederick were detained in handcuffs for investigation of assault.

Both were escorted to patrol cars, and interviewed separately. I interviewed Tara, and Ofc Smith interviewed Frederick.

Officers checked the apartment interior for a safety sweep. A 6yo child was located in the apartment, safe. Officers located a rounded point common butter knife on the kitchen counter. Ofc Rose took photos of the butter knife.

Tara told me the following, post-Miranda: She and Frederick are separated husband and wife. They have 1 child together. She resides in OR, and he lives here.

Frederick called Tara at 03:00 that morning, and they argued about their child being sick and needing to go to the hospital. Tara drove from OR to here, picked up their child, and brought him to the emergency room. Tara and the child returned to the apartment at 08:00 that morning.

Tara was in the kitchen, making breakfast. Frederick was being disrespectful, and approached Tara. Tara said she held out a butterknife towards Frederick. Frederick said that was assault with a deadly weapon, and tried pulling the butter knife out of her hand. Tara said she and he wrestled over control of the butter knife. Tara called her sister and Frederick called Police.

-Tara initiated the physical confrontation by pointing the butter knife at Frederick.

-Tara does not live with Frederick, and could have left at any point.

-Frederick called Police

This was alleged to have occurred in the presence of their 6yo child.

Ofc Rose transported Tara to Clark County Jail, where she was booked and cited for 1 count of Assault 4-DV.

NARRATIVE**Synopsis**

Narrative

On 12/23/2025 at approximately 0838 hours I self-dispatched to a report of a disturbance with a knife at Green Leaf River Pointe apartments, 3508 NE 109th Ave, Apt W5. Call notes were fragmented and information was limited. What I was able to determine was Frederick Howe had called in and that he was physical altercation with a female, later identified as Tara Howe, who was armed with a kitchen knife. The call disconnected and despite the call takers trying to call back for further information little else was known.

I arrived on scene a short time later with multiple other units. As I was heading to take up position on the back of the apartment it was radio broadcast that both Frederick and Tara were coming out of the residence and then detained shortly thereafter. I was informed that Frederick and Tara had a young child, Tormond Howe, inside the residence. Tormond is a 6-year-old male who has a severe autism and is nonverbal. I located Tormond inside the apartment watching television and eating breakfast, Tormond seemed happy and unaware of what had happened.

I then returned to Frederick who was now sitting in the back of my patrol car. I read Frederick his Miranda rights from a department issued card and asked if he understood his rights, Frederick said he did. I also informed Frederick that our conversation was being audio and video recorded. Frederick related the following in substance:

He and his now ex-wife, Tara Howe, have been separated for some time with Tara not living with him in his apartment. The two previously shared joint custody over their son, Tormund, but approximately 3 weeks ago Tara informed Frederick she could no longer support Tormund and gave him to Frederick full time. Frederick went on to explain that he owns a postal annex and this time of year he is extremely busy. To compound things for Frederick, he woke up this morning around 0345 to Tormond throwing up. Frederick said he needed to sleep because he had to work today and reached out to Tara to see if she could take Tormond to the emergency room, Tara reluctantly agreed.

Later in the morning upon Tara and Tormond returning from the doctor's office, Frederick asked Tara how the doctor's visit went. Frederick said this seemed to set Tara off who began verbally berating him, saying things like Frederick is a "shitty dad and a piece of shit" and that she "hopes he dies." Tara then grabbed a nearby butter knife and pointed it at Frederick and demanded that he get out of the apartment. Frederick explained that he was in fear of Tara and did not know what she would do to him with the knife. Frederick noted that he was aware it was only a butter knife, but it was still a knife made out of steel, and he feared for his and his son's safety. With this in mind Frederick said he tried to disarm Tara and take the knife from her. While the two were struggling over the knife, Tara yanked backwards to free the knife, which then caused a small laceration to Frederick's right palm. Frederick then informed Tara that he was going to call 911 to get help. While on the phone with 911, Frederick said he was advised to get his son and leave the house. When Frederick tried to do this, Tara blocked his path and told him that she would not allow him to leave. Tara then changed her mind and told Frederick that she would go make contact with law enforcement first so that she could tell us that Frederick was the aggressor.

I noted a small laceration on Frederick's right palm that looked to have recently stopped bleeding, consistent with what Frederick had told me.

I conferred with Ofc Rich, sharing what I had learned from Frederick. It was determined that Frederick would be released from custody and that Tara was the primary aggressor in this incident. After removing the handcuffs from Frederick's wrists, I asked him to show me the knife Tara used to threaten him with. Frederick led me to a butter knife on the kitchen counter in his apartment that appeared to have breadcrumbs on it. I photographed both the knife and injury to Frederick's hand.

No further action.

Transported Tara Howe and booked her into Clark County Jail. Took photos of the butter knife used by Tara.

Narrative

On 12/23/2025 at about 0838 hours, I self-dispatched to a report of a disturbance with a knife at Green Leaf River Pointe Apartments, located at 3508 NE 109th Ave, Apt W5. The dispatch notes indicated that the disturbance was between a male and female and that a kitchen knife was involved. The reporting party was later identified as the involved male, Frederick Howe, was screaming and saying, "She is assaulting me" referring to the later identified Tara Howe.

Upon arrival, Officers had already detained both Tara and Frederick. I went inside the apartment after learning there was a 6-year-old child who was present for the altercation. I learned later from Tara that the child was named "Tarmond" Howe (DOB:12/24/2019). It should be noted that the child appeared to be on the spectrum and was non-verbal. The child appeared in good spirit and well taken care of but was likely present for the physical disturbance.

I took photos of the kitchen where I observed two butter knives on the counter. I later verified with both Tara and Frederick that the butterknife near the air fryer (not the sink) was the one used during the physical altercation. I have attached these photos to this report.

I transported Tara and booked her into jail without issue. While at jail, Tara advised that her handcuffs were applied too tight. I readjusted both sets of linked handcuffs, checked them for a proper fit and double locked them to prevent any undue discomfort.

I completed pre-book with Officer A. Rich's probable cause statement affixed. Officer A. Rich provided me a criminal citation #5A0234613 which I later provided to Tara at booking.
