Body Worn Camera Disclosure: This incident was recorded on a VPD body worn Camera (BWC). This report is a summarization of the incident.

Synopsis

Arnulfo Rios Espinoza was arrested and booked for Assault IV- DV following an altercation with his ex-girlfriend Marlin Rodriguez.

Narrative

On 11/20/2025 I was employed as a Police Officer with the City of Vancouver Police Department. I was working patrol as 2S43 wearing a fully marked police uniform and driving a fully marked patrol car.

I responded to an Assault at The Evergreen Village Apartments, Unit Q118. Call notes indicated about 20 minutes prior, a man believed to be Arnulfo Rios went into an apartment and beat up a female identified as Marlin Rodriguez.

At approximately 1840 hours, I arrived at the Vancouver Police East Precinct located at 520 SE 155th Avenue. Using a Spanish interpreter, I spoke with Marlin, she stated the following in summary:

She had been in a relationship with Arnulfo Rios Espinoza for about one year, during which time they lived together at the Evergreen Village, unit Q118. About a week ago, they had broken up, and Arnulfo moved most of his belongings out of the apartment and into a storage unit.

Today (11/20) Marlin was on the phone in her room inside of the apartment speaking to her child on the phone. Arnulfo entered her room and grabbed her by her hair. Marlin did not recall which hand Arnulfo grabbed her with but stated she was dragged by her hair into the living area of the apartment.

Arnulfo then grabbed her pants and, in the process, placed his hand on her vagina and "applied pressure". Marlin stated at no point was she penetrated by Arnulfo's hand during this altercation. Her pants were ripped at the time; she did not provide an approximate value for the pants and did not have them with her to show me they were ripped. She was provided an axon.com video link and instructed to upload photos of her ripped pants. She also stated she sustained a cut on her stomach area which I observed, it resembled a fingernail scratch.

Marlin stated Arnulfo went to the kitchen and retrieved a golden knife and threatened to kill himself. Marlin approached Arnulfo, threw him to the ground, and physically forced him out of the apartment. Marlin stated Arnulfo did not threaten her with the knife and had not used it on her. In the course of this "Scuffle" Arnulfo dropped the knife and left the apartment.

Marlin did not know where Arnulfo worked, where he could be living, or what type of vehicle he drove, other than a white work truck with an unknown plate. Marlin provided Arnulfo's phone number. Marlin stated she had not been contacting Arnulfo and had blocked his phone number.

Marlin filled out a Smith Affidavit which indicated a threat score of 10 (see attached).

Pictures were taken of Marlin, and I observed the following: redness on the left side of her face above her eyebrow and on her hairline. She had scratches on her right arm, left hand, and swelling on her left-hand ring finger (see pictures).

I then called Arnulfo on the phone using a Spanish interpreter, he stated the following in summary:

He left the apartment on Sunday and had been contacted by Marlin because she wanted to fix their relationship. When he arrived at the apartment, he found someone else in the house, he admitted to grabbing her and accidentally hitting her in the mouth while she was pushing him. Arnulfo stated he was not injured as a result of the altercation. Arnulfo agreed to meet me at the Vancouver East Precinct so I could take pictures to show he was not injured.

At approximately 2030 hours, Arnulfo arrived at the Vancouver East Precinct driving a white truck (Oregon 950PYK). He was detained in handcuffs which were checked for proper fit and double locked and frisked for weapons, yielding negative results. Using a Spanish interpreter, I read him Miranda warnings using my department issued notebook to which he stated he understood. Arnulfo stated the following in summary:

Arnulfo had a large "goose egg" on his right eyebrow which was swollen, red, and beginning to bruise. He sustained this when Marlin kicked him out of the apartment and he hit his head on a table.

He entered the apartment and saw another male in the apartment, he then went into her room, told her he loved her and told her they were going to fix the relationship. He then squeezed her and grabbed her, which is how she got a bruise on her hand. Arnulfo then denied grabbing Marlin by her hair or hitting her in the face. Arnulfo allowed me to open his phone and look at his messages with Marlin, it showed they were talking for a large portion of the day leading up to the altercation, but I do not understand Spanish and could not read the contents of the messages,

He was placed into the back of a patrol car and notified he was under arrest for Assault IV. I searched his person finding nothing of evidentiary value. His vehicle was secured and left in the Vancouver Police East Precinct parking lot.

I transported and booked him into the Clark County Jail with his belongings, to include a citation for Assault IV - DV.

Due to Arnulfo being on the lease, and having a right to enter the residence, I could not establish probable cause for Residential Burglary-DV. Due to not being able to verify Marlin's pants were damaged, I could not establish probable cause for Malicious Mischief III-DV. Due to no indication Arnulfo grabbed Marlin's vagina with sexual motivation, or penetrated her vagina with his hand, I could not establish probable cause for Assault IV- with sexual motivation or Rape III.

**Synopsis**

Arnulfo Rios Espinoza was arrested and booked for Assault IV- DV following an altercation with his ex-girlfriend Marlin Rodriguez.

**Narrative**

On 11/20/2025 I was employed as a Police Officer with the City of Vancouver Police Department. I was working patrol as 2S43 wearing a fully marked police uniform and driving a fully marked patrol car.

I responded to an Assault at The Evergreen Village Apartments, Unit Q118. Call notes indicated about 20 minutes prior, a man believed to be Arnulfo Rios went into an apartment and beat up a female identified as Marlin Rodriguez. The suspect was no longer at the apartment, and Marlin was at the Vancouver East Precinct waiting for contact from an officer.

At approximately 1840 hours, I arrived at the Vancouver Police East Precinct located at 520 SE 155th Avenue. Using a Spanish interpreter, I spoke with Marlin, she stated the following in summary:

She had been in a relationship with Arnulfo Rios Espinoza for about one year, during which time they lived together at the Evergreen Village, unit Q118. About a week ago, they had broken up, and Arnulfo moved most of his belongings out of the apartment and into a storage unit. Arnulfo was on the lease and still had a key to the apartment, but Marlin had changed the locks, and he did not have access to the apartment. Marlin affirmed some of Arnulfo's belongings were still inside of the apartment.

Today (11/20) Marlin was on the phone in her room inside of the apartment speaking to her child on the phone. Arnulfo entered her room and grabbed her by her hair. Marlin did not recall which hand Arnulfo grabbed her with but stated she was dragged by her hair into the living area of the apartment. Arnulfo then used his right hand to punch her in the chest area and face, a total of two punches. I observed redness and slight swelling on the left side of Marlin's face consistent with her statements.

Arnulfo then grabbed her pants and, in the process, placed his hand on her vagina and "applied pressure". Marlin stated at no point was she penetrated by Arnulfo's hand during this altercation. Her pants were ripped at the time; she did not provide an approximate value for the pants and did not have them with her to show me they were ripped. She was provided an axon.com video link and instructed to upload photos of her ripped pants. She also stated she sustained a cut on her stomach area which I observed, it resembled a fingernail scratch.

Marlin stated Arnulfo went to the kitchen and retrieved a golden knife and threatened to kill himself. Marlin approached Arnulfo, threw him to the ground, and physically forced him out of the apartment. Marlin stated Arnulfo did not threaten her with the knife and had not used it on her.
