Synopsis

Jose Miguel Hinojoza Arze drove a vehicle he knew had faulty brakes which resulted in him crashing this vehicle into two other vehicles. Probable cause was established for Reckless Driving.

Narrative

On 10/04/2025, I was working as 2D23, my assigned patrol beat when I was dispatched to NE Andresen Rd/NE Fourth Plain Blvd Vancouver Washington for a non-injury traffic accident.

When I arrived on scene, I contacted the two victims, Michael Wold who was driving a 2016 Subaru WRX WA Plate #CRR7854, and David Nguyen who was driving a 2024 Volkswagon Tiguan WA License #R688289, and Officer Tulenkun interviewed the driver who was reported to have run into them, Jose Hinojoza-Arze, seen driving a 2011 Volkswagon Jetta WA plate #R611295. Prior to speaking to David and Michael, I collected everyone's driver's licenses. Jose informed me that he did not have a valid driver's license and provided me with an expired state identification card. Jose also informed me that he did not have insurance on the vehicle.

Jose told Ofc. Tulenkun, that he had been running errands knowing that the brakes on the vehicle he was driving were faulty and/or not working properly. Jose then attempted to take a right turn onto NE Andresen Rd, when his brakes stopped working and he hit the other vehicles involved.

I observed tire marks on the ground from the eastbound turn lane on Andresen Rd all the way to the far right, northbound lane on NE Fourth Plain Blvd. Based on the statements made by Jose that he knew his brakes were faulty, he did not have a valid driver's license, and he did not have insurance, probable cause was established for Reckless Driving pursuant to RCW 46.61.500.

Jose showed a willful disregard for the safety of persons and property driving with brakes he knew were faulty. This resulted in him causing damage to David Nguyen and Michael Wold's property.

Michael Wold and Jose's vehicle were towed, and an exchange of information was provided to all parties involved.

Jose was provided a criminal citation, and I explained his court date to him. I also explained the traffic infraction tickets he received.
